

Attachment 1 Suspendable Behaviors

In lieu of in-school suspensions, sites will utilize c that provide students site based interventions as well as an opportunity to repair harm. See *Attachment 1* for suggested response matrix by suspendable behavior. Per E (7) 5144.1, a student may be suspended upon a first offense for any of the reasons listed in sections 48900 (a)-(e), or, if due to the nature of the violation, the student's presence causes danger to others.
