Brief Explanation:

The University of California requires all high school and/or districts to update their UC 'a-g' Course Lists annually with the 'a-g' courses that each school will actively offer in the upcoming school year. As in previous years, high schools' 'a-g' course lists will be updated centrally through a districtwide submission, using information schools provide on the 2019–20 UC 'a-g' Course List Worksheets attached to this circular.

Action:

High schools are asked to complete and return via school mail the signed Principal Certification Form (Attachment 2) and updated 2019–20 UC 'a-g' Course List Worksheets (Attachment 3) to Karen Wilson, Office of School Innovation and Integrated Youth Services, Room 2005, Eugene Brucker Education Center by **Friday, May 24, 2019** as described below:

1. 2019-20 UC 'A-G' Course List Update Instructions (Attachment 1)

Please review the updated 'a-g' course information provided in this document and then follow the step-by-step instructions to update the 'a-g' Course List Worksheets in Attachment 3.

2. 2019-20 Principal UC 'A-G Certification Form (Attachment 2)

Principals are responsible for ensuring the accuracy of the courses reported on their high school's UC 'a-g' Course List each year. To that end, a signed Principal Certification Form must be returned with the school's updated 2019-20 Course List Worksheets confirming that the information is accurate and should be submitted as their school's official 2019-20 UC 'a-g' Course List. Worksheets returned without a signed Principal Certification Form will not be processed.

3. UC 'A-G' Course List Worksheets (Attachment 3)

A-g courses are listed on the worksheets by subject area, with a separate worksheet for AP courses. The 'a-g' course choices displayed on the worksheets are the ones that schools made for the 2018-19 school year. These course choices must be updated for 2019-20 to reflect the 'a-g' courses that sites plan to offer in the upcoming school year. Because UC 'a-g' Course Lists are school year-specific, schools should only identify the 'a-g' courses they will actually offer next year when they update their worksheets.

Updates to the 'a-g' worksheets are only used to inform schools' official UC 'a-g' Course Lists; they do **not** affect schools' NCAA Course Lists, which are separately maintained.
